Subscription Changes - February 2024

Dear Member,

We offer a unique Health Insurance service to all members of An Garda Siochana where only Members of An Garda Siochana and their dependants may join. Our members are always our top priority, always putting them first. As a not- for -profit "Friendly" Society, owned and managed by its members, the Committee applies a premium increase only when absolutely necessary and we invest all available funds as prudently and responsibly as possible. – it's all about the benefits and services we can offer to our members now and into the future. We are very conscious about value for money, especially during these difficult times.

That is why we have frozen our subscriptions for 7yrs (July 2017) despite the ever-increased costs in the healthcare market. Since then, the main insurer has increased premiums by 20%. In 2023 alone they applied increases every few months a total increase of 11.8 %. Furthermore in 2020 the Society acknowledged the reduced services available in some private hospitals arising from the fight against the Covid 19 pandemic and gave a refund of premium to members.

Unfortunately, costs continue to rise and the Society like all other medical insurers is not immune from the various cost drivers affecting annual premiums, including, medical inflation, higher energy costs, demand after Covid, expensive new drugs and procedures, increase age profile of members insured, increase charges for services in Private Hospitals along with new technology, the public sector pay deal and the reversal of the Haddington Road Agreement. All these factors have driven up the costs of treatment for our members across the private hospital network and other clinical settings.

Therefore, bearing this in mind, the Management Committee, at this time, feel it is necessary for the Society going forward to introduce some changes to our subscription rates effective from the 1st of February 2024 to deal with the various cost drivers outlined above and to sustain the Society for the next period.

The following are the new subscriptions deductions per pay & pension as of 1st February 2024.
