Proposed Rule Changes from the Management Committee.

Rule 17. COMMITTEE

In the first line of rule 17(b) after the word "office" delete the words "at the conclusion of the AGM" and insert the words "on the first day of May 2025 and on the same date every five years thereafter."

Rule 22. SECRETARY

In the first sentence after the word "qualified" delete the words "member of the Society" and insert the word "person" and continue with the remainder of the rule.

Rule 28. ANNUAL GENERAL MEETING

Insert a new rule 28(a) and 28(b) as follows.

28(a). If, due to unforeseen circumstances the Annual General Meeting is postponed, it shall be rearranged as soon as practicable thereafter and if this is not possible, the Committee may decide to convene a virtual online Annual General Meeting.

28(b). The postponement of an Annual General Meeting in any circumstance shall not interfere with the ongoing management of the Society's affairs or impinge upon or delay the implementation of the rules of the Society.

Rule 35. NOTICES OF MEETINGS OF MEMBERS OF THE SOCIETY

Insert a new Rule 35(a) as follows.

35(a) If the Annual General Meeting is postponed and is reconvened at a later date either at a venue or by virtual online means, it shall be sufficient to provide notice to the membership of the reconvened Annual General Meeting seven days in advance by the means set out in rule 35.

Proposed Rule Changes from a Member of the Society.

Rule 30. MEETING OF THE COMMITTEE

Amend Rule 30 by inserting the following sentences after the word "quarter" " In the event of a Public Health Emergency or a State of Emergency exists which decrees that gatherings of members of the public are restricted thus preventing the gathering of members of the Committee in a specified place, the Officers of the Society may determine that such meetings be held by electronic means. In circumstances where it is determined by the Officers of the Society that a meeting of the Committee is necessary, as a matter of urgency, such meeting may be held by electronic means following not less than twelve hours' notice of such meeting issued by electronic means. Such provisions shall only take effect when the Officers of the Committee are satisfied that all Committee members have access to facilities for the conduct of such electronic meetings."

Rule 56. TRUSTEES

Amend Rule 56 in line 9 after the words Society, remove the words 'an outgoing trustee shall be eligible for reappointment' and replace with the words, "a trustee who has served a full term as a trustee shall be eligible for re-appointment to one further term only" and continue with the rest of the rule.
